

**FOURTH AMENDMENT TO
AGREEMENT BETWEEN THE CITY OF LOMITA AND NUMA NETWORKS, LLC FOR
PROFESSIONAL SERVICES FOR MANAGED IT SERVICES**

This Fourth Amendment to Agreement 2018-20 for Professional Services, between the City of Lomita ("City") and Numa Networks, LLC ("Consultant"), is made and entered into this 17th day of December 2024.

RECITALS

- A. The City and Consultant entered into the Agreement for professional services related to Managed IT Services ("Agreement") on September 4, 2018.
- B. Amendment No. 1 to the Agreement, dated February 5, 2019, amended the Scope of Services in Exhibit A1 of Amendment No. 1, and amended the Cost Proposal in Exhibit B of the Agreement with additional pricing information in Exhibit B1 of Amendment No. 1.
- C. Amendment No. 2 to the Agreement, dated September 15, 2020, extended the term of the Agreement to September 4, 2023, amended the Scope of Services to include additional specific work identified in Exhibit A of Amendment No. 2, and added associated fees in Exhibit B of Amendment No. 2.
- D. Amendment No. 3 to the Agreement, dated June 6, 2023, further extended the term of the Agreement to September 4, 2026, and repealed and replaced the Cost Proposal in Exhibit B of the Agreement with Exhibit A of Amendment No. 3.
- E. The City and Consultant now desire to enter into this Amendment No. 4 to the Agreement to include one-time professional services and a corresponding one-time payment not included in the typical fee schedule.

In consideration of the promises and mutual covenants contained therein, City and Consultant hereby agree as follows:

- 1. **Scope of Services.** The Scope of Services for this Amendment No. 4 is set forth in Exhibit A-4, attached hereto and incorporated herein by reference.
- 2. **Consideration and Compensation.** The City shall pay the Consultant a one-time payment of \$41,911.30 for the services described in Exhibit A-4. This payment is distinct from and not subject to the ongoing Cost Proposal outlined in Exhibit A of Amendment No. 3.
- 3. **No other changes.** All terms, conditions and other provisions of the Agreement, including all Exhibits thereto, not affected by this Amendment No. 4 shall remain in full force and effect.
- 4. **Signatures.** The City and Consultant agree that this Amendment No. 4 will be considered signed when the signature of a party is delivered by facsimile transmission or scanned and delivered via electronic mail. Such facsimile or electronic mail copies will be treated in all respects as having the same effect as an original signature.
